STRATEGY

Three commitments we have never revised.

01 Control positions

We acquire majority stakes in profitable companies with \$10–60M of EBITDA, partnering with founders and management who stay invested alongside us.

02 Operator-led value creation

Our operating partners have run the businesses they now advise. Value comes from commercial discipline and capability building, not financial engineering.

03 Strategic ownership

We underwrite for sustainable growth, not an exit window. Disciplined ownership lets compounding, not leverage, do the work.
